Contract Agreement

THIS AGREEMENT made the 10th day of February 2019 between Project Director, "Establishment of 1000 Kilowatt Medium Wave Transmitter at Super power transmitting Station of Bangladesh Betar" Administrative Building, Bangladesh Betar, Sher-E-Bangla Nagar, Agargaon, Dhaka-1207, Bangladesh. 
