Contract Agreement

THIS AGREEMENT made the 21 November, 2017 between Project Director, "Establishment of Two Self Contained 10 Kilowatt F.M Radio Stations at Mymensingh & Gopalganj" Project, Bangladesh Betar, Sher-E-angla Nagar, Dhaka-1207 (hereinafter called "the Procuring Entity") of the one part and ALOOK REFRIGERATION CO.LTD., 47/1 SHAHID TAJUDDIN AHMED SHARANI, MOHAKHALI, DHAKA-1212 (hereinafter called "the Contractor") of the other part:

WHEREAS the Procuring Entity invited Tenders for certain works, viz, " Provide and installation of 50 Ton Central Air condition plant including duct and other ancillary equipment for Studio Block at Bangladesh Betar, Mymensingh & Bangladesh Betar, Gopalganj " and has accepted a Tender by the Contractor for the execution of those works in the sum of Taka 2,66,65,448.226 (Taka Two Crore Sixty Six Lakh Sixty Five Thousand Four hundred and Forty Eight point Two two six) only (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (e) the General Conditions of Contract
 - (f) the Technical Specifications
 - (g) the General Specifications
 - (h) the Drawings
 - (i) the priced BOQ and the Schedules
 - (j) any other document listed in the **PCC** forming part of the Contract.
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Entity to execute and complete the works and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
